OFFICE MEMORANDUM

Subject: Clarification regarding exhibition of Public Service Awareness (PSA) Films in Cinema Theatres under Guidelines dated 30.11.2023 issued by Ministry of Information & Broadcasting - reg.

References have been received in Ministry of Information & Broadcasting seeking clarification regarding the interpretation of the Guidelines for exhibition of Public Service Awareness (PSA) Films in Cinema Theatres issued vide this Ministry's Office Memorandum No. M-14014/3/2014-DO(FA) dated 30.11.2023, particularly with regard to the duration of PSA films and the time slots prescribed for their exhibition.

2. In this regard, attention is invited to Paragraphs 5 and 6 of the aforesaid Guidelines. Paragraph 5 prescribes that the duration of Approved/PSA Films of the Central Government shall be up to 2 minutes. It further provides that the State Governments may also provide PSA films up to 2 minutes in duration for exhibition in cinema theatres. Paragraph 6 specifies that the PSA films may be exhibited during the 10-minute pre-show period before the commencement of the film and during the last 5 minutes of the interval before the second half of the movie package.

3. It is hereby clarified that the maximum permissible duration prescribed under Paragraph 5 of the Guidelines is up to 2 minutes in respect of the PSA films of the Central Government and, separately, up to 2 minutes in respect of the PSA films of the concerned State Government. Accordingly, a PSA film of up to 2 minutes' duration of the Central Government and a PSA film of up to 2 minutes' duration of the concerned State Government may each be exhibited in any one of the prescribed time slots, i.e., either during the 10-minute pre-show period before the commencement of the film or during the last 5 minutes of the interval before the second half of the movie package.

4. It is further clarified that where the duration of PSA film(s) is 1 minute or less, the same may be exhibited in both the aforesaid time slots, provided that the overall duration of PSA film(s) exhibited does not exceed the limit of 2 minutes prescribed under Paragraph 5 of the Guidelines.

5. All concerned stakeholders are requested to regulate the exhibition of PSA films in cinema theatres in accordance with the above clarification.
